LOWER SEMICONTINUOUS FUNCTIONALS FOR ALMGREN'S MULTIPLE VALUED FUNCTIONS

Abstract. We consider general integral functionals on the Sobolev spaces of multiple valued functions introduced by Almgren. We characterize the semicontinuous ones and recover earlier results of Mattila in [10] as a particular case. Moreover, we answer positively to one of the questions raised by Mattila in the same paper.

0. Introduction

In his big regularity paper [1], Almgren developed a new theory of weakly differentiable multiple valued maps minimizing a suitable generalization of the classical Dirichlet energy. He considered maps defined on a Lipschitz domain $\Omega \subset \mathbf{R}^m$ and taking values in the space of Q unordered points of \mathbf{R}^n , which minimize the integral of the squared norm of the derivative (conveniently defined). The regularity theory for these so called Dir-minimizing Q-valued maps is a cornerstone in his celebrated proof that the Hausdorff dimension of the singular set of an m-dimensional area-minimizing current is at most (m-2).

The existence of Dir-minimizing functions with prescribed boundary data is proven in [1] via the direct method in the calculus of variations. Thus, the generalized Dirichlet energy is semicontinuous under weak convergence. This property is not specific of the energy considered by Almgren. Mattila in [10] considered some energies induced by homogeneous quadratic polynomials of the partial derivatives. His energies are the first non-constant term in the Taylor expansion of elliptic geometric integrands and hence generalize Almgren's Dirichlet functional, which is the first non-constant term in the area functional.

Mattila showed that these quadratic functionals are lower semicontinuous under weak convergence. A novelty in Mattila's work was the impossibility to use Almgren's extrinsic biLipschitz embeddings of the space of Q-points into a Euclidean space, because of the more complicated form of the energies (cp. with [1] and [5] for the existence and properties of these embeddings). In this paper we push forward the investigation of Mattila and, taking advantage of the intrinsic metric theory for Qvalued functions developed in [5], we generalize his results to the case of general integral functionals defined on Sobolev spaces of Q-functions. We obtain a complete

characterization of the semicontinuity and a simple criterion to recognize efficiently a specific class of semicontinuous functionals. Mattila's Q-semielliptic energies fall obviously into this class. Indeed, a simple corollary of our analysis is that a quadratic energy as considered in [10] is Q-semielliptic if and only if it is quasiconvex (see Definition 0.1 and Remark 2.1 for the relevant definitions). Moreover, in the special cases of dimensions m = 2 or n = 2, we can answer positively to the question posed by Mattila himself on the equivalence of Q-semiellipticity and 1-semiellipticity.

0.1. Quasiconvexity and lower semicontinuity. In order to illustrate the results, we introduce the following terminology (we refer to [5] and Subsection 1.1 for the relevant definitions and terminology concerning Q-valued maps).

Let $\Omega \subset \mathbf{R}^m$ be a bounded open set. A measurable map $f: \Omega \times (\mathbf{R}^n)^Q \times (\mathbf{R}^{m \times n})^Q \to \mathbf{R}$ is called a *Q*-integrand if, for every permutation π of $\{1, \ldots, Q\}$,

$$f(x, a_1, \dots, a_Q, A_1, \dots, A_Q) = f(x, a_{\pi(1)}, \dots, a_{\pi(Q)}, A_{\pi(1)}, \dots, A_{\pi(Q)}).$$

Note that, by (1.2) (see also [5, Remark 1.11]), given a weakly differentiable Q-valued map u, the expression $f(\cdot, u, Du) = f(\cdot, u_1, \ldots, u_Q, Du_1, \ldots, Du_Q)$ is well defined almost everywhere in Ω . Thus, for any Sobolev Q-valued function the following energy makes sense:

(0.1)
$$F(u) = \int_{\Omega} f(x, u(x), Du(x)) dx$$

Our characterization of (weakly) lower-semicontinuous functionals F is the counterpart of Morrey's celebrated result in the vectorial calculus of the variations (see [11], [12]). We start by introducing the relevant notion of quasiconvexity, which is a suitable generalization of Morrey's definition. From now on we set $C_r := [-r/2, r/2]^m$.

Definition 0.1. (Quasiconvexity) Let $f: (\mathbf{R}^n)^Q \times (\mathbf{R}^{m \times n})^Q \to \mathbf{R}$ be a locally bounded *Q*-integrand. We say that f is *quasiconvex* if the following holds for every affine *Q*-valued function $u(x) = \sum_{j=1}^{J} q_j [\![a_j + L_j \cdot x]\!]$, with $a_i \neq a_j$ for $i \neq j$. Given any collection of maps $w^j \in W^{1,\infty}(C_1, \mathscr{A}_{q_j})$ with $w^j|_{\partial C_1} = q_j [\![a_j + L_j]_{\partial C_1}]\!]$ we have the inequality

(0.2)
$$f(u(0), Du(0)) \leq \int_{C_1} f(\underbrace{a_1, \dots, a_1}_{q_1}, \dots, \underbrace{a_J, \dots, a_J}_{q_J}, Dw^1(x), \dots, Dw^J(x)) dx.$$

The main result is the following.

Theorem 0.2. Let $p \in [1, \infty[$ and $f \colon \Omega \times (\mathbf{R}^n)^Q \times (\mathbf{R}^{m \times n})^Q \to \mathbf{R}$ be a continuous Q-integrand. If $f(x, \cdot, \cdot)$ is quasiconvex for every $x \in \Omega$ and

$$0 \le f(x, a, A) \le C(1 + |a|^q + |A|^p)$$
 for some constant C,

where q = 0 if p > m, $q = p^*$ if p < m and $q \ge 1$ is any exponent if p = m, then the functional F in (0.1) is weakly lower semicontinuous in $W^{1,p}(\Omega, \mathscr{A}_Q(\mathbf{R}^n))$. Conversely, if F is weakly^{*} lower semicontinuous in $W^{1,\infty}(\Omega, \mathscr{A}_Q(\mathbf{R}^n))$, then $f(x, \cdot, \cdot)$ is quasiconvex for every $x \in \Omega$.

Remark 0.3. It is easy to see that a quadratic integrand is *Q*-semielliptic in the sense of Mattila if and only if it is quasiconvex, cp. to Remark 2.1.

0.2. Polyconvexity. We continue to follow the classical path of the vectorial calculus of variations and introduce a suitable generalization of the well-known notion of polyconvexity (see [12], [2]). Let $N := \min\{m, n\}, \tau(n, m) := \sum_{k=1}^{N} {m \choose k} {n \choose k}$ and define $M : \mathbf{R}^{n \times m} \to \mathbf{R}^{\tau(m,n)}$ as $M(A) := (A, \operatorname{adj}_2 A, \ldots, \operatorname{adj}_N A)$, where $\operatorname{adj}_k A$ stands for the matrix of all $k \times k$ minors of A.

Definition 0.4. A *Q*-integrand $f: (\mathbf{R}^n)^Q \times (\mathbf{R}^{n \times m})^Q \to \mathbf{R}$ is *polyconvex* if there exists a map $g: (\mathbf{R}^n)^Q \times (\mathbf{R}^{\tau(m,n)})^Q \to \mathbf{R}$ such that:

- (i) the function $g(a_1, \ldots, a_Q, \cdot)$: $(\mathbf{R}^{\tau(m,n)})^Q \to \mathbf{R}$ is convex for every $a_1, \ldots, a_Q \in \mathbf{R}^n$,
- (ii) for every $a_1, \ldots, a_Q \in \mathbf{R}^n$ and $(L_1, \ldots, L_Q) \in (\mathbf{R}^{n \times m})^Q$ it holds

(0.3)
$$f(a_1, \ldots, a_Q, L_1, \ldots, L_Q) = g(a_1, \ldots, a_Q, M(L_1), \ldots, M(L_Q)).$$

Polyconvexity is much easier to verify. For instance, if $\min\{m, n\} \leq 2$, quadratic integrands are polyconvex if and only if they are 1-semielliptic in the sense of Mattila, cp. to Remark 3.4. Combining this with Remark 0.3 and Theorem 0.5, we easily conclude that Q-semiellipticity and 1-semiellipticity coincide in this case, as suggested by Mattila himself in [10].

Theorem 0.5. Every locally bounded polyconvex Q-integrand f is Q-quasiconvex.

For integrands on single valued maps, the classical proof of Theorem 0.5 relies on suitable integration by parts formulas, called Piola's identities by some authors. These identities can be shown by direct computation. However, an elegant way to derive them is to rewrite the quantities involved as integrals of suitable differential forms over the graph of the given map. The integration by parts is then explained via Stokes' Theorem. This point of view is the starting of the theory of Cartesian currents developed by Giaquinta, Modica and Souček (see the monograph [8, 9]). Here we take this approach to derive similar identities in the case of Q-valued maps, building on the obvious structure of current induced by the graph of Lipschitz Qvalued maps $f: \Omega \to \mathscr{A}_Q(\mathbb{R}^n)$ (which we denote by $\operatorname{gr}(f)$). A key role is played by the intuitive identity $\partial \operatorname{gr}(f) = \operatorname{gr}(f|_{\partial\Omega})$, which for Q-valued maps is less obvious. A rather lengthy proof of this fact was given for the first time in [1]. We refer to Appendix C of [4] for a much shorter derivation. A final comment is in order. Due to the combinatorial complexity of Q-valued maps, we do not know whether Theorem 0.5 can be proved without using the theory of currents.

The paper is organized in three sections. The first one contains three technical lemmas on Q-valued Sobolev functions, proved using the language of [5] (which differs slightly from Almgren's original one). In Section 2 we prove Theorem 0.2 and in Section 3 Theorem 0.5. In the appendix we collect some results on equi-integrable functions, essentially small variants of Chacon's biting lemma, which have already appeared in the literature: we include their proofs for reader's convenience.

1. *Q*-valued functions

In this section we recall the notation and terminology of [5], and provide some preliminary results which will be used in the proofs of Theorem 0.2 and Theorem 0.5.

1.1. Sobolev Q-valued functions. Q-valued functions are maps valued in the complete metric space of unordered sets of Q points in \mathbb{R}^n .

Definition 1.1. We denote by $(\mathscr{A}_Q(\mathbf{R}^n), \mathscr{G})$ the metric space of unordered Q-tuples given by

$$\mathscr{A}_Q(\mathbf{R}^n) := \left\{ \sum_{i=1}^Q \llbracket P_i \rrbracket : P_i \in \mathbf{R}^n \text{ for every } i = 1, \dots, Q \right\},$$

where $\llbracket P_i \rrbracket$ denotes the Dirac mass in $P_i \in \mathbf{R}^n$ and

$$\mathscr{G}(T_1, T_2) := \min_{\sigma \in \mathscr{P}_Q} \sqrt{\sum_i |P_i - S_{\sigma(i)}|^2},$$

with $T_1 = \sum_i \llbracket P_i \rrbracket$ and $T_2 = \sum_i \llbracket S_i \rrbracket \in \mathscr{A}_Q(\mathbf{R}^n)$, and \mathscr{P}_Q denotes the group of permutations of $\{1, \ldots, Q\}$.

Given a vector $v \in \mathbf{R}^n$, we denote by $\tau_v(T)$ the translation of the Q-point $T = \sum_i [T_i]$ under v given by

(1.1)
$$\tau_v(T) := \sum_i \llbracket T_i - v \rrbracket.$$

Continuous, Lipschitz, Hölder and (Lebesgue) measurable functions from Ω into \mathscr{A}_Q are defined in the usual way. It is a general fact that any measurable Q-valued function $u: \Omega \to \mathscr{A}_Q$ can be written as the "sum" of Q-measurable functions u_1, \ldots, u_Q [5, Proposition 0.4]:

$$u(x) = \sum_{i} \llbracket u_i(x) \rrbracket$$
 for a.e. $x \in \Omega$.

We now recall the definition of the Sobolev spaces of functions taking values in the metric space of Q-points.

Definition 1.2. A measurable $u: \Omega \to \mathscr{A}_Q$ is in the Sobolev class $W^{1,p}, 1 \leq p \leq \infty$, if there exists $\varphi \in L^p(\Omega; [0, +\infty))$ such that

- (i) $x \mapsto \mathscr{G}(u(x), T) \in W^{1,p}(\Omega)$ for all $T \in \mathscr{A}_Q$;
- (ii) $|D\mathscr{G}(u,T)| \leq \varphi$ a.e. in Ω for all $T \in \mathscr{A}_Q$.

As for classical Sobolev maps, an important feature of Sobolev Q-valued functions is the existence of the approximate differential almost everywhere. Given $u \in W^{1,p}(\Omega, \mathscr{A}_Q(\mathbf{R}^n))$, there exists a Q map $Du = \sum_i [Du_i] : \Omega \to \mathscr{A}_Q(\mathbf{R}^{m \times n})$ such that, for almost every $x_0 \in \Omega$, the first order approximation

(1.2)
$$T_{x_0}u(x) := \sum_i \left[Du_i(x_0) \cdot (x - x_0) + u_i(x_0) \right]$$

satisfies the following:

- (i) there exists a set $\hat{\Omega}$ with density one at x_0 such that $\mathscr{G}(u(x), T_{x_0}u) = o(|x x_0|)$ as $x \to x_0, x \in \tilde{\Omega}$;
- (ii) $Du_i(x_0) = Du_j(x_0)$ if $u_i(x_0) = u_j(x_0)$.

Moreover, the map Du is L^p integrable, meaning that

$$|Du| := \sqrt{\sum_{i} |Du_i|^2} \in L^p(\Omega).$$

Finally, we recall the definition of weak convergence in $W^{1,p}(\Omega, \mathscr{A}_Q(\mathbf{R}^n))$.

Definition 1.3. Let $u_k, u \in W^{1,p}(\Omega; \mathscr{A}_Q)$. We say that u_k converges weakly to u for $k \to \infty$, (and we write $u_k \rightharpoonup u$) in $W^{1,p}(\Omega; \mathscr{A}_Q)$, if

- (i) $\int \mathscr{G}(f_k, f)^p \to 0$, for $k \to \infty$;
- (ii) $\sup_k \int |Df_k|^p < \infty$.

1.2. L^p -approximate differentiability. Here we prove a more refined differentiability result.

Lemma 1.4. Let $u \in W^{1,p}(\Omega, \mathscr{A}_Q)$. Then, for \mathscr{L}^m -a.e. $x_0 \in \Omega$ it holds

(1.3)
$$\lim_{\rho \to 0} \rho^{-p-m} \int_{C_{\rho}(x_0)} \mathscr{G}^p(u, T_{x_0}u) = 0.$$

Proof. By the Lipschitz approximation in [5, Proposition 4.4], there exists a family of functions (u_{λ}) such that:

- (a) Lip $(u_{\lambda}) \leq \lambda$ and $d_{W^{1,p}}(u, u_{\lambda}) = o(1)$ as $\lambda \to +\infty$;
- (b) the sets $\Omega_{\lambda} = \{x \colon T_x u = T_x u_{\lambda}\}$ satisfy $\Omega_{\lambda} \subset \Omega_{\lambda'}$ for $\lambda < \lambda'$ and $\mathscr{L}^m(\Omega \setminus \Omega_{\lambda}) = o(1)$ as $\lambda \to +\infty$.

We prove (1.3) for the points $x_0 \in \Omega_{\lambda}$ which are Lebesgue points for $\chi_{\Omega_{\lambda}}$ and $|Du|^p \chi_{\Omega \setminus \Omega_{\lambda}}$, for some $\lambda \in \mathbf{N}$, that is

(1.4)
$$\lim_{\rho \to 0} \oint_{C_{\rho}(x_0)} \chi_{\Omega_{\lambda}} = 1 \quad \text{and} \quad \lim_{\rho \to 0} \oint_{C_{\rho}(x_0)} |Du|^p \chi_{\Omega \setminus \Omega_{\lambda}} = 0.$$

Let, indeed, x_0 be a point as in (1.4) for a fixed Ω_{λ} . Then,

(1.5)
$$\begin{aligned} \int_{C_{\rho}(x_{0})} \mathscr{G}^{p}(u, T_{x_{0}}u) &\leq 2^{p-1} \int_{C_{\rho}(x_{0})} \mathscr{G}^{p}(u_{\lambda}, T_{x_{0}}u_{\lambda}) + 2^{p-1} \int_{C_{\rho}(x_{0})} \mathscr{G}^{p}(u_{\lambda}, u) \\ &\leq o(\rho^{p}) + C\rho^{p-m} \int_{C_{\rho}(x_{0}) \setminus \Omega_{\lambda}} |D(\mathscr{G}(u_{\lambda}, u))|^{p}, \end{aligned}$$

where in the latter inequality we used Rademacher's theorem for Q-functions (see [5, Theorem 1.13]) and a Poincaré inequality for the classical Sobolev function $\mathscr{G}(u, u_{\lambda})$ which by (1.4) satisfies

$$\Omega_{\lambda} \subseteq \left\{ \mathscr{G}(u, u_{\lambda}) = 0 \right\} \quad \text{and} \quad \rho^{-m} \mathscr{L}^m(C_{\rho}(x_0) \cap \Omega_{\lambda}) \ge 1/2 \quad \text{for small } \rho.$$

Since $\mathscr{G}(u, u_{\lambda}) = \sup_{T_i} |\mathscr{G}(u, T_i) - \mathscr{G}(T_i, u_{\lambda})|$ and $D|\mathscr{G}(u, T_i) - \mathscr{G}(T_i, u_{\lambda})| \leq |D\mathscr{G}(u, T_i)| + |D\mathscr{G}(T_i, u_{\lambda})| \leq |Du| + |Du_{\lambda}| \quad \mathscr{L}^m$ -a.e. on Ω , we conclude (recall that $\lambda \leq C|Du|$ on $\Omega \setminus \Omega_{\lambda}$)

$$\rho^{p-m} \int_{C_{\rho}(x_{0})\backslash\Omega_{\lambda}} |D(\mathscr{G}(u,u_{\lambda}))|^{p} \leq \rho^{p-m} \int_{C_{\rho}(x_{0})\backslash\Omega_{\lambda}} \sup_{i} \left(D|\mathscr{G}(u,T_{i}) - \mathscr{G}(T_{i},u_{\lambda})| \right)^{p} \\ \leq C\rho^{p-m} \int_{C_{\rho}(x_{0})\backslash\Omega_{\lambda}} |Du|^{p} \stackrel{(1.4)}{=} o(\rho^{p}),$$

which finishes the proof.

1.3. Equi-integrability. In the first lemma we show how a weakly convergent sequence of Q-functions can be truncated in order to obtain an equi-integrable sequence still weakly converging to the same limit. This result is the analog of [7,

Lemma 2.3] for Q-valued functions and constitute a main point in the proof of the sufficiency of quasiconvexity for the lower semicontinuity. Details on equi-integrability can be found in the Appendix.

Lemma 1.5. Let $(v_k) \subset W^{1,p}(\Omega, \mathscr{A}_Q)$ be weakly converging to u. Then, there exists a subsequence (v_{k_j}) and a sequence $(u_j) \subset W^{1,\infty}(\Omega, \mathscr{A}_Q)$ such that

- (i) $\mathscr{L}^m(\{v_{k_j} \neq u_j\}) = o(1)$ and $u_j \rightharpoonup u$ in $W^{1,p}(\Omega, \mathscr{A}_Q)$;
- (ii) $(|Du_j|^p)$ is equi-integrable;
- (iii) if $p \in [1, m)$, $(|u_j|^{p^*})$ is equi-integrable and, if p = m, $(|u_j|^q)$ is equi-integrable for any $q \ge 1$.

Proof. Let $g_k := M^p(|Dv_k|)$ and notice that, by the estimate on the maximal function operator (see [13] for instance), $(g_k) \subset L^1(\Omega)$ is a bounded sequence. Applying Chacon's biting lemma (see Lemma A.2 in the Appendix) to (g_k) , we get a subsequence (k_j) and a sequence $t_j \nearrow +\infty$ such that $(g_{k_j} \wedge t_j)$ are equi-integrable.

Let $\Omega_j := \{x \in \Omega: g_{k_j}(x) \leq t_j\}$ and u_j be the Lipschitz extension of $v_{k_j}|_{\Omega_j}$ with Lipschitz constant $ct_j^{1/p}$ (see [5, Theorem 1.7]). Then, following [5, Proposition 4.4], it is easy to verify that $\mathscr{L}^m(\Omega \setminus \Omega_j) = o(t_j^{-1})$ and $d_{W^{1,p}}(u_j, v_{k_j}) = o(1)$. Thus, (i) follows immediately from these properties and (ii) from

$$|Du_j|^p = |Dv_{k_j}|^p \le g_{k_j} \wedge t_j \text{ on } \Omega_j \text{ and } |Du_j|^p \le c t_j = c (g_{k_j} \wedge t_j) \text{ on } \Omega \setminus \Omega_j.$$

As for (iii), note that the functions $f_j := \mathscr{G}(u_j, Q \llbracket 0 \rrbracket)$ are in $W^{1,p}(\Omega)$, with $|Df_j| \le |Du_j|$ by the very definition of metric space valued Sobolev maps. Moreover, by (i), f_j converge weakly to |u|, since $|||u| - f_j||_{L^p} \le ||\mathscr{G}(u, u_j)||_{L^p}$. Hence, $(|f_j|^p)$ and $(|Df_j|^p)$ are equi-integrable. In case $p \in [1, m)$, this implies (see Lemma A.3) the equi-integrability of $(|u_j|^{p^*})$. In case p = m, the property follows from Hölder inequality and Sobolev embedding (details are left to the reader).

1.4. Averaged equi-integrability. The next lemma gives some properties of sequences of functions whose blow-ups are equi-integrable. In what follows a function $\varphi: [0, +\infty] \to [0, +\infty]$ is said superlinear at infinity if $\lim_{t\uparrow+\infty} \frac{\varphi(t)}{t} = +\infty$.

Lemma 1.6. Let $g_k \in L^1(\Omega)$ with $g_k \geq 0$ and $\sup_k \oint_{C_{\rho_k}} \varphi(g_k) < +\infty$, where $\rho_k \downarrow 0$ and φ is superlinear at infinity. Then, it holds

(1.6)
$$\lim_{t \to +\infty} \left(\sup_{k} \rho_k^{-m} \int_{\{g_k \ge t\}} g_k \right) = 0$$

and, for sets $A_k \subseteq C_{\rho_k}$ such that $\mathscr{L}^m(A_k) = o(\rho_k^m)$,

(1.7)
$$\lim_{k \to +\infty} \rho_k^{-m} \int_{A_k} g_k = 0.$$

Proof. Using the superlinearity of φ , for every $\varepsilon > 0$ there exists R > 0 such that $t \leq \varepsilon \varphi(t)$ for every $t \geq R$, so that

(1.8)
$$\limsup_{t \to +\infty} \left(\sup_{k} \rho_k^{-m} \int_{\{g_k \ge t\}} g_k \right) \le \varepsilon \sup_{k} \oint_{C_{\rho_k}} \varphi(g_k) \le C \varepsilon.$$

Then, (1.6) follows as $\varepsilon \downarrow 0$. For what concerns (1.7), we have

$$\rho_k^{-m} \int_{A_k} g_k = \rho_k^{-m} \int_{A_k \cap \{g_k \le t\}} g_k + \rho_k^{-m} \int_{A_k \cap \{g_k \ge t\}} g_k \le t \rho_k^{-m} \mathscr{L}^m(A_k) + \sup_k \rho_k^{-m} \int_{\{g_k \ge t\}} g_k.$$

By the hypothesis $\mathscr{L}^m(A_k) = o(\rho_k^m)$, taking the limit as k tends to $+\infty$ and then as t tends to $+\infty$, by (1.6) the right hand side above vanishes.

1.5. Push-forward of currents under *Q*-functions. We define now the integer rectifiable current associated to the graph of a *Q*-valued function. As for Lipschitz single valued functions, we can associate to the graph of a Lipschitz *Q*-function $u: \Omega \to \mathscr{A}_Q$ a rectifiable current $T_{u,\Omega}$ defined by

(1.9)
$$\langle T_{u,\Omega},\omega\rangle = \int_{\Omega} \sum_{i} \langle \omega(x,u_i(x)), \vec{T}_{u_i}(x)\rangle d\mathscr{H}^m(x) \quad \forall \,\omega \in \mathscr{D}^m(\mathbf{R}^{m+n})$$

where $\vec{T}_{u_i}(x)$ is the *m*-vector given by $(e_1 + \partial_1 u_i(x)) \wedge \cdots \wedge (e_m + \partial_m u_i(x)) \in \Lambda_m(\mathbf{R}^{m+n})$. In coordinates, writing $\omega(x, y) = \sum_{l=1}^N \sum_{|\alpha|=|\beta|=l} \omega_{\alpha\beta}^l(x, y) dx_{\bar{\alpha}} \wedge dy_{\beta}$, where $\bar{\alpha}$ denotes the complementary multi-index of α , the current $T_{u,\Omega}$ acts in the following way:

(1.10)
$$\langle T_{u,\Omega},\omega\rangle = \int_{\Omega} \sum_{i=1}^{Q} \sum_{l=1}^{N} \sum_{|\alpha|=|\beta|=l} \sigma_{\alpha} \,\omega_{\alpha\beta}^{l} \big(x, u_{i}(x)\big) M_{\alpha\beta} \big(Du_{i}(x)\big) dx,$$

with $\sigma_{\alpha} \in \{-1, 1\}$ the sign of the permutation ordering $(\alpha, \bar{\alpha})$ in the natural increasing order and $M_{\alpha\beta}(A)$ denoting the α, β minor of a matrix $A \in \mathbf{R}^{n \times m}$,

$$M_{\alpha\beta}(A) := \det \begin{pmatrix} A_{\alpha_1\beta_1} & \dots & A_{\alpha_1\beta_k} \\ \vdots & \ddots & \vdots \\ A_{\alpha_k\beta_1} & \dots & A_{\alpha_k\beta_k} \end{pmatrix}.$$

Analogously, assuming that Ω is a Lipschitz domain, using parametrizations of the boundary, one can define the current associate to the graph of u restricted to $\partial\Omega$, and both $T_{u,\Omega}$ and $T_{u,\partial\Omega}$ turn out to be rectifiable current—see [4, Appendix C]. The main result about the graphs of Lipschitz Q-functions we are going to use is the following theorem proven in [4, Theorem C.3].

Theorem 1.7. For every Ω Lipschitz domain and $u \in \text{Lip}(\Omega, \mathscr{A}_Q), \ \partial T_{u,\Omega} = T_{u,\partial\Omega}$.

2. Quasiconvexity and lower semicontinuity

In this section we prove Theorem 0.2. Before starting, we link our notion of quasiconvexity with the Q-semiellipticity introduced in [10].

Remark 2.1. Following Mattila, a quadratic integrand is a function of the form

$$E(u) := \int_{\Omega} \sum_{i} \langle ADu_i, Du_i \rangle$$

where $\mathbf{R}^{n \times m} \ni M \mapsto AM \in \mathbf{R}^{n \times m}$ is a linear symmetric map. This integrand is called *Q*-semielliptic if

(2.1)
$$\int_{\mathbf{R}^m} \sum_i \langle ADf_i, Df_i \rangle \ge 0 \quad \forall \ f \in \operatorname{Lip}(\mathbf{R}^m, \mathscr{A}_Q) \text{ with compact support.}$$

Obviously a *Q*-semielliptic quadratic integrand is *k*-semielliptic for every $k \leq Q$. We now show that *Q*-semiellipticity and quasiconvexity coincide. Indeed, consider a linear map $x \mapsto L \cdot x$ and a Lipschitz *k*-valued function $g(x) = \sum_{i=1}^{k} [f_i(x) + L \cdot x]$, where $f = \sum_{i} \llbracket f_i \rrbracket$ is compactly supported in C_1 and $k \leq Q$. Recall the notation $\eta \circ f = k^{-1} \sum_{i} f_i$ and the chain rule formulas in [5, Section 1.3.1]. Then,

$$E(g) = E(f) + k \langle A L, L \rangle + 2 \int_{C_1} \sum_i \langle A L, Df_i \rangle$$

= $E(f) + k \langle A L, L \rangle + 2k \int_{C_1} \langle A L, D(\eta \circ f) \rangle = E(f) + k \langle A L, L \rangle,$

where the last equality follows integrating by parts. This equality obviously implies the equivalence of Q-semiellipticity and quasiconvexity.

2.1. Sufficiency of quasiconvexity. We prove that, given a sequence $(v_k) \subset W^{1,p}(\Omega, \mathscr{A}_Q)$ weakly converging to $u \in W^{1,p}(\Omega, \mathscr{A}_Q)$ and f as in the statement of Theorem 0.2, then

(2.2)
$$F(u) \le \liminf_{k \to \infty} F(v_k).$$

Up to extracting a subsequence, we may assume that the inferior limit in (2.2) is actually a limit (in what follows, for the sake of convenience, subsequences will never be relabeled). Moreover, using Lemma 1.5, again up to a subsequence, there exists (u_k) such that (i)–(iii) in Lemma 1.5 hold. If we prove

(2.3)
$$F(u) \le \lim_{k \to \infty} F(u_k),$$

then (2.2) follows, since, by the equi-integrability properties (ii) and (iii),

$$F(u_k) = \int_{\{v_k = u_k\}} f(x, v_k, Dv_k) + \int_{\{v_k \neq u_k\}} f(x, u_k, Du_k)$$

$$\leq F(v_k) + C \int_{\{v_k \neq u_k\}} (1 + |u_k|^q + |Du_k|^p) = F(v_k) + o(1).$$

For the sequel, we will fix a function $\varphi \colon [0, +\infty) \to [0, +\infty]$ superlinear at infinity such that

(2.4)
$$\sup_{k} \int_{\Omega} \left(\varphi(|u_{k}|^{q}) + \varphi(|Du_{k}|^{p}) \right) dx < +\infty.$$

In order to prove (2.3), it suffices to show that there exists a subset of full measure $\tilde{\Omega} \subseteq \Omega$ such that for $x_0 \in \tilde{\Omega}$ we have

(2.5)
$$f(x_0, u(x_0), Du(x_0)) \le \frac{d\mu}{d\mathscr{L}^m}(x_0),$$

where μ is the weak^{*} limit in the sense of measure of any converging subsequence of $(f(x, u_k, Du_k)\mathscr{L}^m \sqcup \Omega)$. We choose $\tilde{\Omega}$ to be the set of points x_0 which satisfy (1.3) in Lemma 1.4 and, for a fixed subsequence with $(\varphi(|u_k|^q) + \varphi(|Du_k|^p))\mathscr{L}^m \sqcup \Omega \rightharpoonup^* \nu$, satisfy

(2.6)
$$\frac{d\nu}{d\mathscr{L}^m}(x_0) < +\infty.$$

Note that such $\tilde{\Omega}$ has full measure by the standard Lebesgue differentiation theory of measure and Lemma 1.4.

We prove (2.5) by a blow-up argument following Fonseca and Müller [6]. Since in the space \mathscr{A}_Q translations make sense only for Q multiplicity points, blow-ups of Q-valued functions are not well-defined in general. Hence, to carry on this approach,

we need first to decompose the approximating functions u_k according to the structure of the first order-approximation $T_{x_0}u$ of the limit, in such a way to reduce to the case of full multiplicity tangent planes.

Claim 1. Let $x_0 \in \tilde{\Omega}$ and $u(x_0) = \sum_{j=1}^{J} q_j [\![a_j]\!]$, with $a_i \neq a_j$ for $i \neq j$. Then, there exist $\rho_k \downarrow 0$ and $(w_k) \subseteq W^{1,\infty}(C_{\rho_k}(x_0), \mathscr{A}_Q)$ such that:

- (a) $w_k = \sum_{j=1}^J \llbracket w_k^j \rrbracket$ with $w_k^j \in W^{1,\infty}(C_{\rho_k}(x_0), \mathscr{A}_{q_j}), \, \|\mathscr{G}(w_k, u(x_0))\|_{L^{\infty}(C_{\rho_k}(x_0))} = o(1)$ and $\mathscr{G}(w_k(x), u(x_0))^2 = \sum_{j=1}^J \mathscr{G}(w_k^j(x), q_j \llbracket a_j \rrbracket)^2$ for every $x \in C_{\rho_k}(x_0)$;
- (b) $\oint_{C_{\rho_k}(x_0)} \mathscr{G}^p(w_k, T_{x_0}u) = o(\rho_k^p);$
- (c) $\lim_{k\uparrow+\infty} \int_{C_{\rho_k}(x_0)} f(x_0, u(x_0), Dw_k) = \frac{d\mu}{d\mathscr{L}^m}(x_0).$

Proof. We choose radii ρ_k which satisfy the following conditions:

(2.7)
$$\sup_{k} \oint_{C_{\rho_{k}}(x_{0})} \left(\varphi(|u_{k}|^{q}) + \varphi(|Du_{k}|^{p})\right) < +\infty$$

(2.8)
$$\int_{C_{\rho_k}(x_0)} f(x, u_k, Du_k) \to \frac{d\mu}{d\mathscr{L}^m}(x_0),$$

(2.9)
$$\int_{C_{\rho_k}(x_0)} \mathscr{G}^p(u_k, u) = o(\rho_k^p) \quad \text{and} \quad \int_{C_{\rho_k}(x_0)} \mathscr{G}^p(u_k, T_{x_0}u) = o(\rho_k^p).$$

As for (2.7) and (2.8), since

 $(\varphi(|u_k|^q) + \varphi(|Du_k|^p)) \mathscr{L}^m \sqcup \Omega \rightharpoonup^* \nu \text{ and } f(x, u_k, Du_k) \mathscr{L}^m \sqcup \Omega \rightharpoonup^* \mu,$

we only need to check that $\nu(\partial C_{\rho_k}(x_0)) = \mu(\partial C_{\rho_k}(x_0)) = 0$ (see for instance Proposition 2.7 of [3]). Fixed such radii, for every k we can choose a term in the sequence (u_k) in such a way that the first half of (2.9) holds (because of the strong convergence of (u_k) to u): the second half is, hence, consequence of (1.3).

Set $r_k = 2 |Du|(x_0) \rho_k$ and consider the retraction maps $\vartheta_k \colon \mathscr{A}_Q \to \overline{B}_{r_k}(u(x_0)) \subset \mathscr{A}_Q$ constructed in [5, Lemma 3.7] (note that for k sufficiently large, these maps are well defined). The functions $w_k := \vartheta_k \circ u_k$ satisfy the conclusions of the claim.

Indeed, since ϑ_k takes values in $\overline{B}_{r_k}(u(x_0)) \subset \mathscr{A}_Q$ and $r_k \to 0$, (a) follows straightforwardly. As for (b), the choice of r_k implies that $\vartheta_k \circ T_{x_0}u = T_{x_0}u$ on $C_{\rho_k}(x_0)$, because

(2.10)
$$\mathscr{G}(T_{x_0}u(x), u(x_0)) \le |Du(x_0)| |x - x_0| \le |Du(x_0)| \rho_k = \frac{r_k}{2}.$$

Hence, being $\operatorname{Lip}(\vartheta_k) \leq 1$, from (2.9) we conclude

$$\oint_{C_{\rho_k}(x_0)} \mathscr{G}^p(w_k, T_{x_0}u) = \oint_{C_{\rho_k}(x_0)} \mathscr{G}^p(\vartheta_k \circ u_k, \vartheta_k \circ T_{x_0}u) \le \oint_{C_{\rho_k}(x_0)} \mathscr{G}^p(u_k, T_{x_0}u) = o(\rho_k^p).$$

To prove (c), set $A_k = \{w_k \neq u_k\} = \{\mathscr{G}(u_k, u(x_0)) > r_k\}$ and note that, by Chebychev's inequality, we have

$$\begin{aligned} r_k^p \mathscr{L}^m(A_k) &\leq \int_{A_k} \mathscr{G}^p(u_k, u(x_0)) \leq 2^{p-1} \int_{A_k} \mathscr{G}^p(u_k, T_{x_0}u) + 2^{p-1} \int_{A_k} \mathscr{G}^p(T_{x_0}u, u(x_0)) \\ &\stackrel{(2.9), (2.10)}{\leq} o(\rho_k^{m+p}) + \frac{r_k^p}{2} \mathscr{L}^m(A_k), \end{aligned}$$

which in turn implies

(2.11)
$$\mathscr{L}^m(A_k) = o(\rho_k^m).$$

Using Lemma 1.6, we prove that

(2.12)
$$\lim_{k \to +\infty} \left(\oint_{C_{\rho_k}(x_0)} f(x_0, u(x_0), Dw_k) - \oint_{C_{\rho_k}(x_0)} f(x, w_k, Dw_k) \right) = 0.$$

Indeed, for every t > 0,

$$\begin{aligned} \left| \int_{C_{\rho_{k}}(x_{0})} f(x_{0}, u(x_{0}), Dw_{k}) - \int_{C_{\rho_{k}}(x_{0})} f(x, w_{k}, Dw_{k}) \right| \\ \leq \rho_{k}^{-m} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} \left(f(x_{0}, u(x_{0}), Dw_{k}) + f(x, w_{k}, Dw_{k}) \right) \\ + \rho_{k}^{-m} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| < t\}} \left| f(x_{0}, u(x_{0}), Dw_{k}) - f(x, w_{k}, Dw_{k}) \right| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q} + |Dw_{k}|^{p}) + \omega_{f,t}(\rho_{k} + ||\mathscr{G}(w_{k}, u(x_{0})||_{L^{\infty}}), dw_{k}) + \omega_{f,t}(\rho_{k}) \| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q} + |Dw_{k}|^{p}) + \omega_{f,t}(\rho_{k}) \| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q} + |Dw_{k}|^{p}) + \omega_{f,t}(\rho_{k}) \| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q} + |Dw_{k}|^{p}) + \omega_{f,t}(\rho_{k}) \| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q} + |Dw_{k}|^{p}) + \omega_{f,t}(\rho_{k}) \| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q} + |Dw_{k}|^{p}) + \omega_{f,t}(\rho_{k}) \| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q} + |Dw_{k}|^{p}) + \omega_{f,t}(\rho_{k}) \| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q} + |Dw_{k}|^{p}) + \omega_{f,t}(\rho_{k}) \| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q} + |Dw_{k}|^{p}) + \omega_{f,t}(\rho_{k}) \| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q} + |Dw_{k}|^{p}) + \omega_{f,t}(\rho_{k}) \| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q} + |w_{k}|^{p}) + \omega_{f,t}(\rho_{k}) \| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q}) + (1 + |w_{k}|^{q}) \| \\ \leq \sup_{k} \frac{C}{\rho_{k}^{m}} \int_{C_{\rho_{k}}(x_{0}) \cap \{|Dw_{k}| \ge t\}} (1 + |w_{k}|^{q}) + (1 + |w_{k}|^{q}) \|$$

where $\omega_{f,t}$ is a modulus of continuity for f restricted to the compact set $\overline{C}_{\rho_1}(x_0) \times \overline{B}_{|u(x_0)|+1} \times \overline{B}_t \subset \Omega \times (\mathbb{R}^n)^Q \times (\mathbb{R}^{m+n})^Q$. To fully justify the last inequality we remark that we choose the same order of the gradients in both integrands so that the order for $u(x_0)$ and for w_k is the one giving the L^{∞} distance between them. Then, (2.12) follows by passing to the limit in (2.13) first as $k \to +\infty$ and then as $t \to +\infty$ thanks to (1.6) in Lemma 1.6 applied to $1 + |w_k|^q$ (which is equi-bounded in $L^{\infty}(C_{\rho_k}(x_0))$ and, hence, equi-integrable) and to $|Dw_k|^p$.

Thus, in order to show item (c), it suffices to prove

(2.14)
$$\lim_{k \to +\infty} \left(\oint_{C_{\rho_k}(x_0)} f(x, u_k, Du_k) - \oint_{C_{\rho_k}(x_0)} f(x, w_k, Dw_k) \right) = 0.$$

By the definition of A_k , we have

$$\left| \int_{C_{\rho_k}(x_0)} f(x, u_k, Du_k) - \int_{C_{\rho_k}(x_0)} f(x, w_k, Dw_k) \right| \\ \leq \rho_k^{-m} \int_{A_k} \left(f(x, u_k, Du_k) + f(x, w_k, Dw_k) \right) \\ \leq \frac{C}{\rho_k^m} \int_{A_k} \left(1 + |w_k|^q + |u_k|^q + |Dw_k|^p + |Du_k|^p \right).$$

Hence, by the equi-integrability of u_k , w_k and their gradients, and by (2.11), we can conclude from (1.7) of Lemma 1.6

Using Claim 1, we can now "blow-up" the functions w_k and conclude the proof of (2.5). More precisely we will show:

Claim 2. For every $\gamma > 0$, there exist $(z_k) \subset W^{1,\infty}(C_1, \mathscr{A}_Q)$ such that $z_k|_{\partial C_1} = T_{x_0}u|_{\partial C_1}$ for every k and

(2.15)
$$\limsup_{k \to +\infty} \int_{C_1} f(x_0, u(x_0), Dz_k) \leq \frac{d\mu}{d\mathscr{L}^m}(x_0) + \gamma.$$

Assuming the claim and testing the definition of quasiconvexity of $f(x_0, \cdot, \cdot)$ through the z_k 's, by (2.15), we get

$$f(x_0, u(x_0), Du(x_0)) \le \limsup_{k \to +\infty} \int_{C_1} f(x_0, u(x_0), Dz_k) \le \frac{d\mu}{d\mathscr{L}^m}(x_0) + \gamma,$$

which implies (2.5) by letting $\gamma \downarrow 0$ and concludes the proof.

Proof of Claim 2. We consider the functions w_k of Claim 1 and, since they have full multiplicity at x_0 , we can blow-up. Let $\zeta_k := \sum_{j=1}^J \left[\!\!\left[\zeta_k^j\right]\!\!\right]$ with the maps $\zeta_k^j \in W^{1,\infty}(C_1, \mathscr{A}_{q_j})$ defined by $\zeta_k^j(y) := \tau_{-a_j} \left(\rho_k^{-1} \tau_{a_j}(w_k^j)(x_0 + \rho_k \cdot)\right)(y)$, with τ_{-a_j} defined in (1.1). Clearly, a simple change of variables gives

(2.16)
$$\zeta_k^j \to q_j \llbracket a_j + L_j \cdot \rrbracket \quad \text{in } L^p(C_1, \mathscr{A}_{q_j})$$

and, by Claim 1 (c),

(2.17)
$$\lim_{k \to +\infty} \int_{C_1} f(x_0, u(x_0), D\zeta_k) = \frac{d\mu}{d\mathscr{L}^m}(x_0).$$

Now, we modify the sequence (ζ_k) into a new sequence (z_k) in order to satisfy the boundary conditions and (2.15). For every $\delta > 0$, we find $r \in (1 - \delta, 1)$ such that

(2.18)
$$\liminf_{k \to +\infty} \int_{\partial C_r} |D\zeta_k|^p \le \frac{C}{\delta} \quad \text{and} \quad \lim_{k \to +\infty} \int_{\partial C_r} \mathscr{G}^p(\zeta_k, T_{x_0}u) = 0.$$

Indeed, by using Fatou's lemma, we have

$$\int_{1-\delta}^{1} \liminf_{k \to +\infty} \int_{\partial C_s} |D\zeta_k|^p \, ds \leq \liminf_{k \to +\infty} \int_{C_1 \setminus C_{1-\delta}} |D\zeta_k|^p \leq C,$$
$$\int_{1-\delta}^{1} \lim_{k \to +\infty} \int_{\partial C_s} \mathscr{G}^p(\zeta_k, T_{x_0}u) \, ds \leq \liminf_{k \to +\infty} \int_{C_1 \setminus C_{1-\delta}} \mathscr{G}^p(\zeta_k, T_{x_0}u) \stackrel{(2.16)}{=} 0,$$

which together with the mean value theorem gives (2.18). Then we fix $\varepsilon > 0$ such that $r(1 + \varepsilon) < 1$ and we apply the interpolation result [5, Lemma 2.15] to infer the existence of a function $z_k \in W^{1,\infty}(C_1, \mathscr{A}_Q)$ such that $z_k|_{C_r} = \zeta_k|_{C_r}, z_k|_{C_1 \setminus C_{r(1+\varepsilon)}} = T_{x_0}u|_{C_1 \setminus C_{r(1+\varepsilon)}}$ and

$$\int_{C_{r(1+\varepsilon)\setminus C_r}} |Dz_k|^p \leq C \varepsilon r \left(\int_{\partial C_r} |D\zeta_k|^p + \int_{\partial C_r} |DT_{x_0}u|^p \right) + \frac{C}{\varepsilon r} \int_{\partial C_r} \mathscr{G}^p(\zeta_k, T_{x_0}u) \\$$
(2.19)
$$\leq C \varepsilon (1+\delta^{-1}) + \frac{C}{\varepsilon} \int_{\partial C_r} \mathscr{G}^p(\zeta_k, T_{x_0}u).$$

Therefore, by (2.19), we infer

$$\int_{C_1} f(x_0, u(x_0), Dz_k) = \int_{C_r} f(x_0, u(x_0), D\zeta_k)$$

+
$$\int_{C_{r(1+\varepsilon)} \setminus C_r} f(x_0, u(x_0), Dz_k) + \int_{C_1 \setminus C_{r(1+\varepsilon)}} f(x_0, u(x_0), Du(x_0))$$

$$\leq \int_{C_1} f(x_0, u(x_0), D\zeta_k) + C \varepsilon (1 + \delta^{-1}) + \frac{C}{\varepsilon} \int_{\partial C_r} \mathscr{G}^p(\zeta_k, T_{x_0}u) + C\delta.$$

Choosing $\delta > 0$ and $\varepsilon > 0$ such that $C \varepsilon (1 + \delta^{-1}) + C\delta \leq \gamma$, and taking the superior limit as k goes to $+\infty$ in the latter inequality, we get (2.15) thanks to (2.17) and (2.18).

2.2. Necessity of quasiconvexity. We now prove that, if F is weak^{*}- $W^{1,\infty}$ lower semicontinuous, then $f(x_0, \cdot, \cdot)$ is Q-quasiconvex for every $x_0 \in \Omega$. Without loss of generality, assume $x_0 = 0$ and fix an affine Q-function u and functions w^j as in Definition 0.1. Set $z^j(y) := \sum_{i=1}^{q_j} [(w^j(y))_i - a_j - L_j \cdot y]]$, so that $z^j|_{\partial C_1} = q_j [[0]]$, and extend it by C_1 -periodicity.

We consider $v_k^j(y) = \sum_{i=1}^{q_j} \llbracket k^{-1}(z^j(ky))_i + a_j + L_j \cdot y \rrbracket$ and, for every r > 0 such that $C_r \subseteq \Omega$, we define $u_{k,r}(x) = \sum_{j=1}^J \tau_{(r-1)a_j} \left(r v_k^j (r^{-1}x) \right)$. Note that:

- (a) for every $r, u_{k,r} \to u$ in $L^{\infty}(C_r, \mathscr{A}_Q)$ as $k \to +\infty$;
- (b) $u_{k,r}|_{\partial C_r} = u|_{\partial C_r}$ for every k and r;
- (c) for every k, $u_{k,r}(0) = \sum_{j=1}^{J} \tau_{-a_j} (r/k z^j(0)) \to u(0)$ as $r \to 0$;
- (d) for every r, $\sup_k |||Du_{k,r}|||_{L^{\infty}(C_r)} < +\infty$, since

$$|Du_{k,r}|^{2}(x) = \sum_{j=1}^{J} |Dv_{k}^{j}|^{2} (r^{-1}x) = \sum_{j=1}^{J} \sum_{i=1}^{q_{j}} |Dz_{i}^{j} (k r^{-1}x) + L_{j}|^{2}$$

From (a) and (d) it follows that, for every r, $u_{k,r} \rightharpoonup^* u$ in $W^{1,\infty}(C_r, \mathscr{A}_Q)$ as $k \to +\infty$. Then, by (b), setting $u_{k,r} = u$ on $\Omega \setminus C_r$, the lower semicontinuity of F implies that

(2.20)
$$F(u,C_r) := \int_{C_r} f(x,u,Du) \leq \liminf_{k \to +\infty} F(u_{k,r},C_r).$$

By the definition of $u_{k,r}$, changing the variables in (2.20), we get

(2.21)
$$\int_{C_1} f(ry, \underbrace{a_1 + r \, L_1 \cdot y}_{q_1}, \dots, \underbrace{a_J + r \, L_J \cdot y}_{q_J}, L_1, \dots, L_J) dy$$
$$\leq \liminf_{k \to \infty} \int_{C_1} f(ry, \tau_{(r-1)a_1}(rv_k^1(y)), \dots, \tau_{(r-1)a_J}(rv_k^J(y)), Dv_k^1(y), \dots, Dv_k^J(y)) dy.$$

Noting that $\tau_{(r-1)a_j}(r v_k^j(y)) \to q_j \llbracket a_j \rrbracket$ in $L^{\infty}(C_1, \mathscr{A}_{q_j})$ as r tends to 0 and $Dv_k^j(y) = \tau_{-L_j}(Dz^j(ky))$, (2.21) leads to

$$(2.22) f\left(0, \underbrace{a_{1}, \ldots, a_{1}}_{q_{1}}, \ldots, \underbrace{a_{J}, \ldots, a_{J}}_{q_{J}}, L_{1}, \ldots, L_{J}\right)$$
$$\leq \liminf_{k \to \infty} \int_{C_{1}} f\left(0, \underbrace{a_{1}, \ldots, a_{1}}_{q_{1}}, \ldots, \underbrace{a_{J}, \ldots, a_{J}}_{q_{J}}, \tau_{-L_{1}}(Dz^{1}(ky)), \ldots, \tau_{-L_{J}}(Dz^{J}(ky))\right) dy.$$

Using the periodicity of z^{j} , the integral on the right hand side of (2.22) equals

$$\int_{C_1} f\left(0, \underbrace{a_1, \ldots, a_1}_{q_1}, \ldots, \underbrace{a_J, \ldots, a_J}_{q_J}, \tau_{-L_1}(Dz^1(y)), \ldots, \tau_{-L_J}(Dz^J(y))\right) dy.$$

Since $\tau_{-L_i}(Dz^j) = Dw^j$, we conclude (0.2).

3. Polyconvexity

In this section we prove Theorem 0.5 and show the semicontinuity of Almgren's Dirichlet energy and Mattila's quadratic energies. Recall the notation for multiindices and minors $M_{\alpha,\beta}$ introduced in Section 1.

Definition 3.1. A map $P: \mathbf{R}^{n \times m} \to \mathbf{R}$ is polyaffine if there are constants $c_0, c_{\alpha\beta}^l$, for $l \in \{1, \ldots, N\}$ and α, β multi-indices, such that

(3.1)
$$P(A) = c_0 + \sum_{l=1}^{N} \sum_{|\alpha| = |\beta| = l} c_{\alpha\beta}^l M_{\alpha\beta}(A) = c_0 + \langle \zeta, M(A) \rangle,$$

where $\zeta \in \mathbf{R}^{\tau(m,n)}$ is the vector whose entries are the $c_{\alpha\beta}^{l}$'s and M(A) is the vector of all minors.

It is possible to represent polyconvex functions as supremum of a family of polyaffine functions retaining some symmetries from the invariance of f under the action of permutations.

Proposition 3.2. Let f be a Q-integrand, then the following are equivalent:

- (i) f is a polyconvex Q-integrand,
- (ii) for every choice of vectors $a_1, \ldots, a_Q \in \mathbf{R}^n$ and matrices $A_1, \ldots, A_Q \in \mathbf{R}^{n \times m}$, with $A_i = A_j$ if $a_i = a_j$, there exist polyaffine functions $P_j \colon \mathbf{R}^{n \times m} \to \mathbf{R}$, with $P_i = P_j$ if $a_i = a_j$, such that

(3.2)
$$f(a_1, \dots, a_Q, A_1, \dots, A_Q) = \sum_{j=1}^Q P_j(A_j),$$

and

(3.3)
$$f(a_1,\ldots,a_Q,L_1,\ldots,L_Q) \ge \sum_{j=1}^Q P_j(L_j) \text{ for every } L_1,\ldots,L_Q \in \mathbf{R}^{n \times m}.$$

Proof. (i) \Rightarrow (ii). Let g be a function representing f according to Definition 0.4. Convexity of the subdifferential of $g(a_1, \ldots, a_Q, \cdot)$, condition (0.3) and the invariance of f under the action of permutations yield that there exists $\zeta \in \partial g(a_1, \ldots, a_Q, M(A_1), \ldots, M(A_Q))$, with $\zeta_i = \zeta_j$ if $a_i = a_j$, such that for every $X \in (\mathbf{R}^{\tau(m,n)})^Q$ we have

 $g(a_1,\ldots,a_Q,X_1,\ldots,X_Q)$

(3.4)
$$\geq g(a_1, \dots, a_Q, M(A_1), \dots, M(A_Q)) + \sum_{j=1}^Q \langle \zeta_j, X_j - M(A_j) \rangle.$$

Hence, the maps $P_j \colon \mathbf{R}^{n \times m} \to \mathbf{R}$ given by

(3.5)
$$P_j(L) := Q^{-1}g(a_1, \dots, a_Q, M(A_1), \dots, M(A_Q)) + \langle \zeta_j, M(L) - M(A_j) \rangle$$

are polyaffine and such that (3.2) and (3.3) follow.

(ii) \Rightarrow (i). By (3.2) and (3.3), there exists ζ_j , satisfying $\zeta_i = \zeta_j$ if $a_i = a_j$, such that

$$f(a_1,\ldots,a_Q,L_1,\ldots,L_Q)$$

$$(3.6) \geq f(a_1,\ldots,a_Q,A_1,\ldots,A_Q) + \sum_{j=1}^Q \langle \zeta_j, M(L_j) - M(A_j) \rangle$$

Then setting,

$$g(a_1, \dots, a_Q, X_1, \dots, X_Q) := \sup \left\{ f(a_1, \dots, a_Q, A_1, \dots, A_Q) + \sum_{j=1}^Q \langle \zeta_j, X_j - M(A_j) \rangle \right\}$$

where the supremum is taken over all $A_1, \ldots, A_Q \in \mathbf{R}^{n \times m}$ with $A_i = A_j$ if $a_i = a_j$, it follows clearly that $g(a_1, \ldots, a_Q, \cdot)$ is a convex function and (0.3) holds thanks to (3.6). In turn, these remarks and the equality $\operatorname{co}((M(\mathbf{R}^{n \times m}))^Q) = (\mathbf{R}^{\tau(m,n)})^Q$ imply that $g(a_1, \ldots, a_Q, \cdot)$ is everywhere finite. \Box

We are now ready for the proof of Theorem 0.5.

Proof of Theorem 0.5. Assume that f is a polyconvex Q-integrand and consider a_j, L_j and w^j as in Definition 0.1. Corresponding to this choice, by Proposition 3.2, there exist polyaffine functions P_j satisfying (3.2) and (3.3), which read as

(3.7)
$$f\left(\underbrace{a_1,\ldots,a_1}_{q_1},\ldots,\underbrace{a_J,\ldots,a_J}_{q_J},\underbrace{L_1,\ldots,L_1}_{q_1},\ldots,\underbrace{L_J,\ldots,L_J}_{q_J}\right) = \sum_{j=1}^J q_j P_j(L_j)$$

and, for every $B_1, \ldots, B_Q \in \mathbf{R}^{m \times n}$,

(3.8)
$$f(\underbrace{a_1, \dots, a_1}_{q_1}, \dots, \underbrace{a_J, \dots, a_J}_{q_J}, B_1, \dots, B_Q) \ge \sum_{j=1}^J \left\{ \sum_{i=\sum_{l < j} q_l+1}^{\sum_{l \le j} q_l} P_j(B_i) \right\}.$$

To prove the theorem it is enough to show that

(3.9)
$$\sum_{j=1}^{J} q_j P_j(L_j) = \int_{C_1} \sum_{j=1}^{J} \sum_{i=1}^{q_j} P_j(Dw_i^j)$$

Indeed, then the quasiconvexity of f follows easily from

$$f\left(\underbrace{a_{1},\ldots,a_{1}}_{q_{1}},\ldots,\underbrace{a_{J},\ldots,a_{J}}_{q_{J}},\underbrace{L_{1},\ldots,L_{1}}_{q_{1}},\ldots,\underbrace{L_{J},\ldots,L_{J}}_{q_{J}}\right) \stackrel{(3.2)}{=} \sum_{j=1}^{J} q_{j} P_{j}(L_{j})$$

$$\stackrel{(3.9)}{=} \int_{C_{1}} \sum_{j=1}^{J} \sum_{i=1}^{q_{j}} P_{j}(Dw_{i}^{j}) \stackrel{(3.3)}{\leq} \int_{C_{1}} f\left(\underbrace{a_{1},\ldots,a_{1}}_{q_{1}},\ldots,\underbrace{a_{J},\ldots,a_{J}}_{q_{J}},Dw^{1},\ldots,Dw^{J}\right)$$

To prove (3.9), consider the current T_{w^j,C_1} associated to the graph of the q_j -valued map w^j and note that, by definition (1.10), for the exact, constant coefficient *m*-form

$$d\omega^{j} = c_{0}^{j} dx + \sum_{l=1}^{N} \sum_{|\alpha|=|\beta|=l} \sigma_{\alpha} c_{\alpha\beta}^{j,l} dx_{\bar{\alpha}} \wedge dy_{\beta}, \text{ it holds}$$

(3.10)
$$\int_{C_1} \sum_{i=1}^{q_j} P_j(Dw_i^j) = \left\langle T_{w^j,C_1}, d\omega^j \right\rangle,$$

where $P_j(A) = c_0^j + \sum_{l=1}^N \sum_{|\alpha|=|\beta|=l} c_{\alpha\beta}^{j,l} M_{\alpha\beta}(A)$. Since $u|_{\partial C_1} = w|_{\partial C_1}$, from Theorem 1.7 it follows that $\partial T_{w,C_1} = \partial T_{u,C_1}$. Then, (3.9) is an easy consequence of (3.10): for $u^j(x) = q_j \llbracket a_j + L_j \cdot x \rrbracket$, one has, indeed,

$$\sum_{j=1}^{J} q_j P_j(L_j) = \int_{C_1} \sum_{j=1}^{J} \sum_{i=1}^{q_j} P_j(Du_i^j) = \sum_{j=1}^{J} \left\langle T_{u^j,C_1}, d\omega^j \right\rangle = \sum_{j=1}^{J} \left\langle \partial T_{u^j,C_1}, \omega^j \right\rangle$$
$$= \sum_{j=1}^{J} \left\langle \partial T_{w^j,C_1}, \omega^j \right\rangle = \sum_{j=1}^{J} \left\langle T_{w^j,C_1}, d\omega^j \right\rangle = \int_{C_1} \sum_{j=1}^{J} \sum_{i=1}^{q_j} P_j(Dw_i^j).$$

This finishes the proof.

Explicit examples of polyconvex functions are collected below (the elementary proof is left to the reader).

Proposition 3.3. The following classes of functions are polyconvex *Q*-integrands:

- (a) $f(a_1,\ldots,a_Q,L_1,\ldots,L_Q) := g(\mathscr{G}(L,Q[0]))$ with $g: \mathbf{R} \to \mathbf{R}$ convex and increasing;
- (b) $f(a_1, \ldots, a_Q, L_1, \ldots, L_Q) := \sum_{i,j=1}^Q g(L_i L_j)$ with $g: \mathbf{R}^{n \times m} \to \mathbf{R}$ convex; (c) $f(a_1, \ldots, a_Q, L_1, \ldots, L_Q) := \sum_{i=1}^Q g(a_i, L_i)$ with $g: \mathbf{R}^m \times \mathbf{R}^{n \times m} \to \mathbf{R}$ measurable and polyconvex

Remark 3.4. Consider as in Remark 2.1 a linear symmetric map $\mathbf{R}^{n \times m} \ni M \mapsto$ $A M \in \mathbf{R}^{n \times m}$. As it is well-known, for classical single valued functions the functional

$$\int \langle A \, Df, Df \rangle$$

is quasiconvex if and only if it is rank-1 convex. If $\min\{m, n\} \leq 2$, quasiconvexity is equivalent to polyconvexity as well (see [14]). Hence, in this case, by Theorem 0.5, every 1-semielliptic integrand is quasiconvex and therefore Q-semielliptic.

We stress that for $\min\{m, n\} \ge 3$ there exist 1-semielliptic integrands which are not polyconvex (see always |14|).

Appendix A. Equi-integrability

Let us first recall some definitions and introduce some notation. As usual, in the following $\Omega \subset \mathbf{R}^m$ denotes a Lipschitz set with finite measure.

Definition A.1. A sequence (q_k) in $L^1(\Omega)$ is *equi-integrable* if one of the following equivalent conditions holds:

- (a) for every $\varepsilon > 0$ there exists $\delta > 0$ such that, for every \mathscr{L}^m -measurable set $E \subseteq \Omega$ with $\mathscr{L}^m(E) \leq \delta$, we have $\sup_k \int_E |g_k| \leq \varepsilon$;
- (b) the distribution functions $\varphi_k(t) := \int_{\{|g_k| \ge t\}} |g_k|$ satisfy $\lim_{t \to +\infty} \sup_k \varphi_k(t) = 0$;

(c) (De la Vallée Poissin's criterion) if there exists a Borel function $\varphi \colon [0, +\infty) \to [0, +\infty]$ such that

(A.1)
$$\lim_{t \to +\infty} \frac{\varphi(t)}{t} = +\infty \quad \text{and} \quad \sup_{k} \int_{\Omega} \varphi(|g_k|) \, dx < +\infty.$$

Note that, since Ω has finite measure, an equi-integrable sequence is also equibounded. We prove now Chacon's biting lemma.

Lemma A.2. Let (g_k) be a bounded sequence in $L^1(\Omega)$. Then, there exist a subsequence (k_j) and a sequence $(t_j) \subset [0, +\infty)$ with $t_j \to +\infty$ such that $(g_{k_j} \lor (-t_j) \land t_j)$ is equi-integrable.

Proof. Without loss of generality, assume $g_k \ge 0$ and consider for every $j \in \mathbf{N}$ the functions $h_k^j := g_k \wedge j$. Since, for every j, $(h_k^j)_k$ is equi-bounded in L^{∞} , up to passing to a subsequence (not relabeled), there exists the L^{∞} weak* limit f_j of h_k^j for every j. Clearly the limits f_j have the following properties:

- (a) $f_j \leq f_{j+1}$ for every j (since $h_k^j \leq h_k^{j+1}$ for every k);
- (b) $\|f_j\|_{L^1} = \lim_k \|h_k^j\|_{L^1};$
- (c) $\sup_{j} \|f_{j}\|_{L^{1}} = \sup_{j} \lim_{k \to \infty} \|h_{k}^{j}\|_{L^{1}} \le \sup_{k} \|g_{k}\|_{L^{1}} < +\infty.$

By the Lebesgue monotone convergence theorem, (a) and (c), it follows that (f_j) converges in L^1 to a function f. Moreover, from (b), for every j we can find a k_j such that

(A.2)
$$\left| \int h_{k_j}^j - \int f_j \right| \le j^{-1}.$$

We claim that $h_{k_j}^j = g_{k_j} \wedge j$ fulfills the conclusion of the lemma (with $t_j = j$). To see this, it is enough to show that $h_{k_j}^j$ weakly converges to f in L^1 , from which the equi-integrability follows. Let $a \in L^{\infty}$ be a test function. Since $h_{k_j}^l \leq h_{k_j}^j$ for $l \leq j$, we have that

(A.3)
$$\int (\|a\|_{L^{\infty}} - a) h_{k_j}^l \leq \int (\|a\|_{L^{\infty}} - a) h_{k_j}^j.$$

Taking the limit as j goes to infinity in (A.3), we obtain (by $h_{k_j}^l \stackrel{w^*-L^{\infty}}{\to} f_l$ and (A.2))

$$\int \left(\|a\|_{L^{\infty}} - a \right) f_l \le \|a\|_{L^{\infty}} \int f - \limsup_j \int a h_{k_j}^j$$

From which, passing to the limit in l, we conclude since $f_l \xrightarrow{L^-} f$

(A.4)
$$\limsup_{j} \int a h_{k_j}^j \le \int a f.$$

Using -a in place of a, one obtains as well the inequality

(A.5)
$$\int af \le \liminf_{j} \int a h_{k_j}^j$$

(A.4) and (A.5) together concludes the proof of the weak convergence of $h_{k_j}^j$ to f in L^1 .

Next we show that concentration effects for critical Sobolev embedding do not show up if equi-integrability of functions and gradients is assumed.

Lemma A.3. Let $p \in [1,m)$ and $(g_k) \subset W^{1,p}(\Omega)$ be such that $(|g_k|^p)$ and $(|\nabla g_k|^p)$ are both equi-integrable, then $(|g_k|^{p^*})$ is equi-integrable as well.

Proof. Since (g_k) is bounded in $W^{1,p}(\Omega)$, Chebychev's inequality implies

(A.6)
$$\sup_{j} j^{p} \mathscr{L}^{m}(\{|g_{k}| > j\}) \leq C < +\infty.$$

For every fixed $j \in \mathbf{N}$, consider the sequence $g_k^j := g_k - (g_k \vee (-j) \wedge j)$. Then, $(g_k^j) \subset W^{1,p}(\Omega)$ and $\nabla g_k^j = \nabla g_k$ in $\{|g_k| > j\}$ and $\nabla g_k^j = 0$ otherwise. The Sobolev embedding yields

(A.7)
$$\|g_k^j\|_{L^{p^*}(\Omega)}^p \le c \|g_k^j\|_{W^{1,p}(\Omega)}^p \le c \int_{\{|g_k|>j\}} \left(|g_k|^p + |\nabla g_k|^p\right) dx.$$

Therefore, the equi-integrability assumptions and (A.6) imply that for every $\varepsilon > 0$ there exists $j_{\varepsilon} \in \mathbf{N}$ such that for every $j \ge j_{\varepsilon}$

(A.8)
$$\sup_{k} \|g_{k}^{j}\|_{L^{p^{*}}(\Omega)} \leq \varepsilon/2.$$

Let $\delta > 0$ and consider a generic \mathscr{L}^m -measurable sets $E \subseteq \Omega$ with $\mathscr{L}^m(E) \leq \delta$. Then, since we have

$$\|g_k\|_{L^{p^*}(E)} \le \|g_k - g_k^{j_{\varepsilon}}\|_{L^{p^*}(E)} + \|g_k^{j_{\varepsilon}}\|_{L^{p^*}(E)} \le j_{\varepsilon} \left(\mathscr{L}^m(E)\right)^{1/p^*} + \|g_k^{j_{\varepsilon}}\|_{L^{p^*}(\Omega)},$$

by (A.8), to conclude it suffices to choose δ such that $j_{\varepsilon} \delta^{1/p^*} \leq \varepsilon/2$.
